Motion by Cory Wilson, seconded by Beth Hendricks to work with First National Bank with the funding of Scotchpine Court. Along with this same motion was the approval of the resolution and the Notice to Proceed. Motion carried unanimously.

Steve Johnson approached the board with his request to spread the chloride on the township roads.

Supervisor Wilson indicated a resident from the township called him and asked to not have chloride applied on Sullivan Road this year. Cory is thinking we should apply chloride to Winding Drive this year maybe instead of Sullivan.
